In 1955 she gave the birth of her second daughter attempted suicide she was encouraged by her doctor to pursue and interest in writing poetry that she had developed in high school and in the fall of 1957, she enrolled in a poetry workshop. In 1974 at the age of 46 she won the Pulitzer Prize for poetry. In 1967 for live or die she lost a battle with mental illness and committed suicide.

Wilderness means the structure of the essay or poem is not in a coherent order. In this poem it can be clearly observed the aspects of the wilderness as: the two poles mentioned in this theory, the difficulties of women as seen in this

poem and the theory, the aspect of Gynocritics, the four aspects: biological, linguistic, psychoanalytical, cultural, and it also focuses on Women's Language, Women's Psyche, Women's Culture.
