Had I been in love, I could not have been more wretchedly blind. But vanity, not love, has been my folly. Pleased with the preference of one, and offended by the neglect of the other, on the very beginning of our acquaintance, I have courted possession and ignorance, and driven reason away where either were concerned. Till this moment I never knew myself"

The author also gives a portrait of male protagonist, Darcy, who first has a pride in nature but finally surrenders in front of Elizabeth's intellect an admirable quality. The portrait character of Elizabeth illustrates a vision to explore in writing especially to the extent that affords her as a female protagonist. Women were considered downtrodden to men in the society and have neither legal right to possess their ancestral property in any form nor control over their own intentions. Novelist focuses on patriarchal views of society and writes about female protagonists who not only tried to change their own life but also impacted the lives of other people as well. "From the very beginning--from the first moment, I may almost say—of my life acquaintance with you, your manners, impressing me with the fullest belief of your arrogance, your conceit and your selfish disdain of the feelings of others, were such as to form groundwork of disapprobation on which succeeding events have built so immovable a dislike; and I had not known you a month before I felt that you were the last man in the world whom I could ever be prevailed on to marry."

She also proves her suitability to Lady Catherine who shows her the high status of Darcy and upset with his decision to marry Elizabeth lower to him in status when she comments "He is a gentleman, and I am a gentleman's daughter. So far we are equal" Elizabeth's assertiveness and outspokenness would have given something new to the reader and affirms her female stereotype. The defiant nature of the heroin displays her real feminism in respect to her denial on several issues in the novel with her feminist approach. That was times' need to change and elevate the status of woman in the society. This vision about life of Charlotte was odious to Elizabeth and she perfectly thinks that woman is not supposed to be the puppet of such irrational things and she has a good sense in her opinion regarding to self-justification.
